## DATA PROTECTION

By sending the reservation you consent to managing and processing your personal data in accordance with the provisions of this privacy policy for the purpose of providing the services you choose.

We are committed to keeping the personal data of those who use our services confidential and we take responsibility for fully complying with the data protection laws in force at all times. In all respects, we comply with data protection legislation, such as Act CXII of 2011 on Informational Self-Determination and Freedom of Information (Privacy Act) and the provisions of other relevant laws. We apply concepts related to personal data in accordance with the provisions of Privacy Act.

Otherwise, we reserve the right to modify the information in this Data Protection Policy without prior notice in accordance with the changes in the relevant legal provisions or legal practice. Our Data Protection Policy displayed on the *cottage.co.hu* website shall always be considered the valid version.

Róbert Fekete is the Service Provider as well as the controller of personal data collected and recorded in connection with the use of the online booking system and newsletters. We process your personal data for market research and advertising purposes when making online reservations or subscribing to our newsletter, especially for the purpose of sending you (as a person who has voluntarily subscribed to our newsletter), promotional and informational newsletters.

We process personal data only based on the consent of our guest or in order to fulfill our legal obligations. Your personal data will be used only by the Service Provider (Róbert Fekete) in accordance with the data management consent you have given, in accordance with the provisions of the relevant legislation. Our data management meets this goal in all stages.

All personal data that you voluntarily make available to us, or that we handle based on the provisions of the relevant legislation, are recorded, managed and processed for the purpose of

providing the services you use. Please provide only the data that is necessary for the services. In this regard, we undertake to fully comply with the following data protection guidelines:

We collect and process personal data fairly and legally.

We only collect personal data for specific, legal purposes and do not use them other than for their intended purpose.

The method of data management and storage is suitable for identifying our guest only for the time necessary for the purpose of data management.

We only manage data that is absolutely necessary for the purpose of data management.

The data we manage are accurate, complete and, if necessary, actual.

Data storage does not take longer than it is necessary to achieve the purpose of use.

During the processing of the data, we fully ensure the rights of the persons concerned contained in Privacy Act and other relevant legislation. We take the technical and organizational measures and develop the procedural rules that are necessary to prevent the unauthorized or illegal use of personal data, as well as the loss, damage or destruction of data. By providing data management consent, you consent to the management, storage and processing of your personal data as described above.

We allow third parties access to the stored data only in the manner described in this Data Protection Policy. We transfer your personal data to a third party only in order to fulfill our legal obligations, or based on your express consent, in compliance with the legal regulations, and only if this person has undertaken to comply with the applicable data protection regulations.

We would like to draw your attention to the fact that you are responsible for the validity of your personal data, we are not responsible for damages resulting from false data. You can request information about the management of your personal data from our company at any time. The contact details of our company are listed in the imprint. At your request we provide detailed information about your data we manage, the purpose, legal basis, duration of data management and our activities related to data management. You can also request the correction, deletion or blocking of your personal data. In addition, you can object to the processing of your personal data in accordance with the applicable legal provisions. If you do not agree with our decision based on your protest, you can appeal to the court within 15 days of its notification.

We also inform you that at your request your personal data stored in our system will be deleted from our system. A request for the deletion of data can be sent to the Service Provider (Róbert Fekete) by mail or e-mail (fekusz@hotmail.com) to one of the contact details in the imprint.
